STEP 1: LIST ALL CHILDREN IN SCHOOL IN THE HOUSEHOLD.

The household's primary wage earner or another adult household member must provide the last four digits of his/her Social Security Number in the space provided. You are eligible to apply for benefits even if you do not have a Social Security Number. If no adult household members have a Social Security Number, leave this space blank and mark the box to the right labeled "Check if no SSN."

All applications must be signed by an adult member of the household. By signing the application, that household member is promising that all information has been truthfully and completely reported. - PROVIDE YOUR CONTACT INFORMATION. Write your current address in the fields provided if this information is available. If you have no permanent address, this does not make your children ineligible for free or
- reduced price school meals. Sharing a phone number, email address, or both is optional, but helps us reach you quickly if we need to contact you.

 PRINT AND SIGN YOUR NAME. Print your name in the box "Printed name of adult completing the form." And sign your name in the box "Signature of adult completing the form."
- SHARE CHILDREN'S RACIAL AND ETHNIC IDENTITIES (OPTIONAL). At the bottom of the application, we ask you to share information about your children's race and ethnicity. This field is optional and does not affect your children's eligibility for free or reduced price school meals

You will be notified when the meal benefit form is approved or denied.

APPEAL: If you do not agree with the District's decision on your form or the result of verification, you may wish to discuss it with school officials. You also may have the right to a fair hearing.
